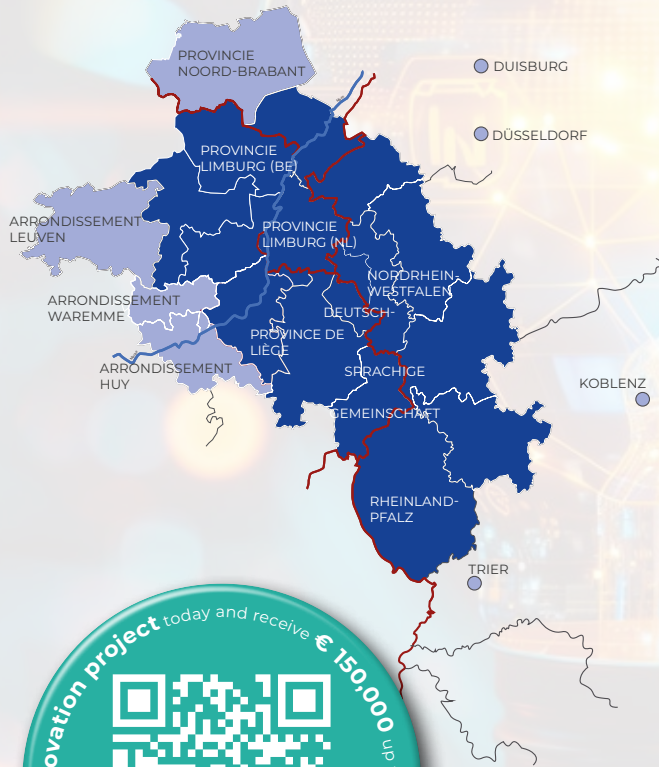


The STIPP funding area

STIPP – Innovation redefined

The border triangle of the Netherlands, Germany and Belgium is an innovative high-tech region with strengths in both research and industry – from SMEs to global companies. The high-tech impulses of this region provide answers to global challenges. The regional science enjoys the highest reputation on international level. The potential of this region can be further strengthened by intensifying the exchange of relevant stakeholders across borders.

STIPP stands for “**SME Transition Innovation Partners Projects**” and is designed to cater to the needs of small and medium enterprises, from **business** development and **consortium building** up to **funding** for innovative cooperation projects.

What does STIPP have to offer and how can STIPP support my company?




The STIPP instrument **covers the entire spectrum of cross-border activities** of innovative entrepreneurs interested in new co-creation partners in the Meuse-Rhine region and supports you with the following services:

- we **identify and approach** potential partner SMEs for your project idea across borders,
- we **organise short cross-border (online) meetings** to get to know those SMEs, you are interested in,
- we support you in setting-up your **cross-border partner consortium** and **project application**,
- your consortium can apply for **attractive fundings** for your innovation project
- we **support** you during your innovation project life-cycle and
- you receive our support for further **market entry** (on request)

STIPP – tackle grand challenges

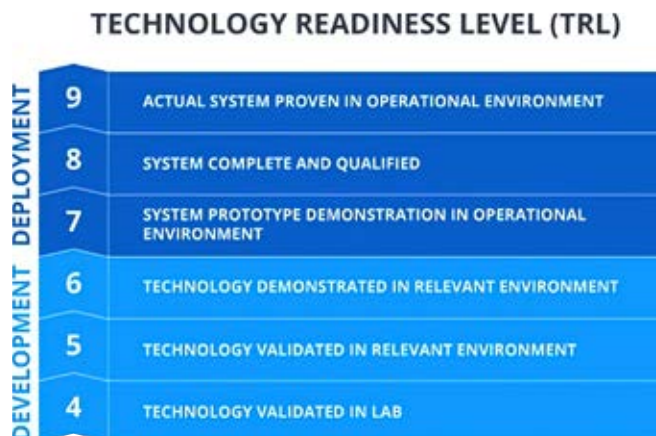
The STIPP instrument has set itself the ambitious goal of meeting some of the major challenges of our time with innovative solutions.

In order to achieve the widest possible range of solutions in the innovation projects, there is no focus on specific technologies. It is important that the cross-border consortia address (at least) one of the following three topics with their innovation project applications:




-  **Industrial Transition**
-  **Green Transformation**
-  **Healthier Citizens**

Compact, innovative and market-oriented projects

The aim of the STIPP instrument is to be close to the market. The initiative is therefore clearly focussed on **Technology Readiness Levels (TRL) from 4 to 9 (preferably 6 or higher)** with a maximum project duration of **24 months**.

-  New calls on a regular basis
-  Available EU-funding of **€ 10.000.000** within the STIPP instrument
-  Project **selection process of 12 weeks**

Conditions

- Min. 2 SMEs from 2 Member States (NL, BE or DE)
- Non-SMEs may participate, but do not receive grants
- SMEs not located in the programme area may participate with limited grants
Further Terms and conditions apply.

Grant

- Participation of more SMEs is preferred
- Grant of 50% in the eligible expenditure
- Maximum grant depending on the composition of the consortium
 - € 150.000 with 2 regions to € 600.000 with 4 regions per project
 - Max. EU-funding per region € 75.000 to € 125.000
